CITY-STATES WITH THE BEST ACCESS TO CREDIT OFTEN HAD THE MOST CLOSED AND OLIGARCHIC SYSTEMS OF REPRESENTATION, HINDERING THEIR ABILITY TO ACCEPT NEW ECONOMIC INNOVATIONS. THIS EVENTUALLY TRANSFORMED CERTAIN CITY-STATES FROM ECONOMIC DYNAMOS INTO RENTIER REPUBLICS.
