Performative manifestations resulted in contradictory characterizations of the painted youth as an aristocrat or a "regular fellow," as masculine or feminine, or as heterosexual or gay. In private and public spaces where viewers saw the actual painting and where living and rendered replicas circulated, Gainsborough's painting was often the centerpiece where dominant and subordinate classes met, gender identities were enacted, and sexuality was implicitly or overtly expressed.

Soviet Impressionist Painting Vern G. Swanson 2008 Soviet Realist art of the 1930s to 1980s was naturalistic, bold, colourful, and exciting. Though it is

now considered the 20th century's major Realist school of painting, during its heyday, thanks to the politics of the Cold War, the treasures of Soviet artists remained hidden, often, if not considered politically correct, languishing for years in artists' studios. Now, art historians are redressing the balance and focussing on the Soviet Impressionist paintings that are passing through the sale rooms of Europe and North America, and are finding their way in to museums in the West. John William Godward Vern G. Swanson 1997 Plucked from oblivion, Godward serves as the last best example of 19th century Greco-Roman Classicism. Of a reclusive nature and painting in a style completely out-of-date with post-war Europe, this genius was and remained obscure. Godward's brilliance, with the recent revival of interest in his fallow Classicists, Alma-Tadema and Lord Leighton, is only now coming to light. Godward's art sought to portray peace, feminine beauty and ideal perfection in an age careening headlong into atrocity. He did so by marvelously painted and composed pictures of beautiful women in halycon classical environments. He was a niche painter whose subject, while arresting, was narrow. However, only Sir Lawrence Alma-Tadema was better at painting this genre of 'patrician women on marble benches'. Melancholia, fed by ill health and increasing artistic criticism overwhelmed his fantasy world of serenity and he died by his own hand.
