This isn't the type of book that will create a fantasy world of how easy it is to get rich quickly with little risk. I'm not writing to promote another business you have to buy in to. Rather than explain how options work in theory, this book explains how to sell naked puts and covered calls by showing actual trade details and my reasoning for each trade decision. Managing risks, keeping a trader's journal and learning from mistakes will help investors minimize losses and improve returns in the long-term. This is my method for achieving my investment goals.
