Lost Pirate Treasures of St. Croix John A. Boyd 2013-06-03 The research of John A. Boyd tracks all known pirate activity on the island of St. Croix. Many pirates brought treasure to the island as did smugglers and merchants. It is well documented that Captain James Martel was killed on the island and half of his fortune lost to time so he certainly rates a Chapter. During his reign, 1640 to 1652, he took a minimum of ten percent of all of the prizes captured by the Buccaneers of Tortuga referred to as the Brethren of the Coast. He also collected taxes on all imports to the island. However, he cheated his partner in this criminal empire, Governor Phillippe de Lonvillers dePoincy of St. Croix, by keeping everything for himself. De Poincy retaliated by conquering Tortuga and claiming the Fortune of La Vasseur as his own. After de Poincy's military conquest of Tortuga, this treasure is also lost to time. The research for this book brings that fortune to St. Croix where it is probably still well hidden.

Through engrossing episodes of roguish glamour and extreme brutality, Dolin depicts the star pirates of this period, among them the towering Blackbeard, the ill-fated Captain Kidd, and sadistic Edward Low, who delighted in torturing his prey. Upending popular misconceptions and cartoonish stereotypes, Black Flags, Blue Waters is a “tour de force history” (Michael Pierce, Midwestern Rewind) of the seafaring outlaws whose raids reflect the precarious nature of American colonial life.
